The sustainable business practices that we have deployed thus far since our company inception on 2009 are listed below.

- We actively seek to recycle all materials, paper and other shipping materials, metal, wood, plastics and glass at our office. All freight materials are reused and/or recycled.
- We utilize environmentally sensitive and low-voc inherently biodegradable oil's paints and lubricants in our elevator services. Any recoverable oil we retrieve is delivered to a local recycling center.
- Any metal we reclaim from a work site is delivered to a local recycling center, as well as batteries, computer hardware, and light bulbs.
- We have implemented a paperless office management culture, leveraging personal equipment devices, cloud services, and collaboration software.
- Hazardous waste is properly inventoried for disposal and delivered to an appropriate Metro location.
- Systematically change out incandescent lighting with LED lighting at all locations we are contracted for.

COST OF OWNERSHIP

This is a focus of our company when discussing elevator maintenance and repairs. We understand the cost pressures our customers face, and have deliberately established our business with a focus on providing value to our employees while keeping our overhead low. With employees having ownership of there work, our productivity and efficiency is maximized, coupled with our quality of work and service. MAINTENANCE CONTROL PROGRAM

We have proactively implemented our AVS Elevator Maintenance Control Program (MCP) for all service customers. The AVS - MCP is written in accordance with A.S.M.E. 17.1 of the latest adopted code 2010. The State of Washington is currently requiring the MCP program, and as a result, it is expected that the State of Oregon will follow soon. Therefore, we are currently working on an updated version to ensure our delivery of service stays current with the newly released code.

Note: The current industry average elevator preventative maintenance is 15 minutes or less for the average lift. We started this company because this norm is unacceptable and is the driving source for the projected national - MCP program's, and that the safety of riding passengers demands more attention; deliberate and assured quality. Thus, our reasoning for proactively developing company required policy of following our AVS Elevator MCP.

CALL BACKS

Once we receive a call back, we systematically troubleshoot by the manufactures recommendations when applicable and repair the problem, and proceed in testing in accordance per the AVS Elevator's MCP to ensure the safety, reliability and longevity of your lift. A summary of the milestones within the MCP is as follows:

1. Respond to call, mobilize on-site, check in with site contact, target 30 minutes.
2. Remedy the problem as directed by the manufacture.
3. Conducting tests per the AVS-MCP and A17 state logs to ensure safety and reliability beyond standard practices.
4. Check out with site contact and relay status of lift.

EMERGENCY CALL BACKS

Emergency callouts can be defined as situations of entrapment of passengers, imminent danger of injury to the general public, imminent danger of damage to elevator equipment or building containing said equipment, or where elevator service disruption restricts the ability individuals to egress building. When AVS receives a call for service, the call is answered 24 hours a day by the AVS - Sound Telecom Network. The call is then immediately transferred to our key personnel. AVS Elevator 24/7 retains two on-call employees who can be to our counties and locations of elevators we provide service to, within 30 minutes. Due to our tracking system and location check-in, our employees are deployed to the emergency based on location, and who can respond to the call and be on-site in the least amount of time. Our licensed and certified employees are prepared to handle any elevator emergency efficiently, safely and professionally.

AVS RESOURCING

AVS Elevator routinely demonstrates worldwide resourcing and technical ability beyond our competitors. Worldwide resourcing in today's markets gives the Independent elevator companies a competitive edge over the majors (Otis, Kone, Thyssen, Schindler), as they confine themselves to their own products and engineering resources. AVS OUTSOURCING

Our resources are dedicated to the customer locally rather than overseas as is with most big box Companies. Because we are locally owned, we have the ability to tap into resources beyond the restrictions that the major conglomerates are locked in to within their own organization. An example of this is the issue that arose with Holiday Retirement Center. The current service provider TKE was unable to repair the main elevator control system. They convinced the customer that a completely new elevator was required (an expense over \$50,000). We were called in because of our relationship with the customer contact, and were able to find a resource in New York that allowed us to repair the elevator. We found a resource beyond the confines of the local elevator industry to solve this issue with a modern PLC control (total expense of \$2,500). This example is one we have seen become a common practice in our area, and our focus on cost of ownership guides our direction. Holiday Retirement Centers', Dennis Giusto – Area Maintenance Director, stated:


